Sub: Eligibility criteria for appearing in the final examinations & submission of marks - reg.

Dear Course Coordinator,

You are requested to kindly note the following in respect of:

- a. Eligibility criteria for appearing in Theory / Practical examinations
 - b. Procedure for submission of marks
1. Last date for internal theory, internal practical & external practical **online mark entry** is 20th May 2020. The hall ticket will be made available to the students only on completion of above 3 categories of marks.
 2. Every candidate has to pass internal practical examinations to be eligible for external practical examinations.
 3. Every candidate has to pass internal theory examinations to be eligible for external theory examinations.
 4. The concerned institutions may conduct re-examination of internal theory and practical examinations for the students who have failed or absent during the internal examinations, before the last date (20th May 2020) scheduled by NIEPMD-NBER.
 5. The students who are absent or fail in the June 2020 Internal Theory Examination will be allowed to re-appear for **both Internal and External Theory Examination only in December 2020 Supplementary Examination.**
 6. The students who are absent or fail in the June 2020 Internal Practical Examination will be allowed to re-appear for **both Internal and External Practical Examination only in June 2021 Examination.**
 7. The students who are absent or fail in June 2020 External Practical examination will be allowed to re-appear for External Practical examination only in June 2021 examination in the concerned subject.

8. Hall ticket will be issued only to the students who have passed the internal theory and internal practical examination in the concerned subject.
9. If no marks are entered/blank or if the student is absent for internal theory and internal practical examination, the student will not be eligible for final examination and no hall ticket will be generated.
10. Internal theory, internal practical and external practical examination marks submitted after the last date (20th of May 2020) will not be considered.
11. After completion of online mark entry kindly take a printout and send to the NIEPMD-NBER on the same day duly signed by the Course coordinator.
12. After completion of external practical examination, enter the marks in the prescribed mark entry form and the same should send to NIEPMD-NBER duly signed by the examiners.
13. The internal marks of both theory and practical should be submitted before conduct of external theory and external practical examinations. Kindly ensure that the internal practical marks reach NIEPMD-NBER, prior to the conduct of External Practical Examination.
14. The marks submitted online to NIEPMD-NBER shall be final and **NO CHANGES** in marks shall be entertained. Therefore, please check and recheck for any typographical or any other errors before submitting marks ONLINE.
15. In case of any discrepancy in the marks submitted online and hardcopy received, the marks obtained as in the HARD COPY received shall only be considered.
