**CIRCULAR**

**Admission to RCI's approved Diploma Level Courses through Centralized Online Admission process for the Academic Session 2020-21**

The Council invited applications from the prospective candidates for admission to RCI's approved Diploma level courses for the academic session 2020-21 through Centralized Online Admission Process.

2. Based on the marks of 12<sup>th</sup> examination submitted by the prospective candidates, the Council has prepared the **National Merit List of general candidates and reserved category (SC/ST/OBC/PWD)** for provisional admission to the eligible candidate(s) as per their choice of course and Institutions, subject to the verification of their original documents such as class 10<sup>th</sup> & 12<sup>th</sup> marksheets, and caste certificate. **State wise, Institute wise, course wise & category wise Merit List of candidates with their name in alphabetical order can be accessed by clicking the link <http://rehabcouncil.nic.in/writereaddata/nationalmerit-2020.pdf>.**

3. Eligible candidates whose names appearing in the **National Merit List** are advised to report to respective allotted Training Institutions along with the requisite original documents for provisional admission within the stipulated time period. **Instructions for the candidates for 1<sup>st</sup> round of admission are attached herewith at Annexure- 'A'.**

4. List of eligible candidates as per the merit list is also being sent separately to all the concerned training institutions through e-mail. All the Heads of the Training Institutions are advised to contact candidates for provisional admission after verification of their class 10<sup>th</sup> & 12<sup>th</sup> marksheets and other requisite certificates during the 1<sup>st</sup> round of admission.

5. On completion of the 1<sup>st</sup> round of admission, Institutions are required to submit the list of provisionally admitted candidates to the Council, for which necessary proforma and guidelines will be issued separately. **Detailed admission guidelines and schedule for 1<sup>st</sup> round of admission for Training Institutions are attached herewith at Annexure- 'B'.**

6. Training Institutions are further advised **NOT to take admissions** of the candidates who secured 90% and above marks in class 12<sup>th</sup> examination and highlighted by the Council in National Merit List. Decision to admit such candidates will be considered after verification of their original marksheet of class 12<sup>th</sup> examination to ascertain the authenticity and genuineness of marks filled by them in their online application forms. Admission to these candidates by the training institutes to be considered only after obtaining approval from the Council.

7. All the Heads of the Training Institutes/ University Department/ National Institutes/ State Institutes/CRCs as well as eligible candidates are advised to carefully go through the instructions and admission guidelines for strict compliance. Any kind of violation/deviations in this regard either by the training institutions or the candidates may result in cancellation of admission/suitable action as deemed fit.
