Sub.: Special Campaign on the theme of 'Sanitation needs for Persons with Disabilities' as a part of 'Special Campaign 2.0' of the Govt. of India:-reg.

Madam/Sir,

The Council is in receipt of a letter No. T-05001/6/2022-Media dated 07.11.2022 (copy attached) on the subject cited above and to inform you that the following actions required to be initiated at your end under the intimation to this Council.

1. The training institutes must display the 'Special Campaign 2.0' on the theme 'Sanitation needs for Persons with Disabilities' with effect of 31.10.2022 for a period of 6 months and to be displayed prominently at the entrance of the training institutions / special school for Children with Special Needs (CWSN).
2. A Standard Operating Procedure (SOP) with regard to sanitation and hygiene required for CWSN to be developed and copy of the same to be circulated to all parents and stake holders including staff members working in the institute.
3. Periodically, short term awareness programme by inviting the local experts dealing with CWSN to be conducted. A special campaign also needs to be carried out specially for the girl child with disability with the help of senior female teaching staff separately and parents to be invited for the said event.
4. The video clips of the lecture / talk organized by the institution to be uploaded on institution's website and also to be provided to parents and other stake holders.

Copy of letter No. T-05001/6/2022-Media dated 07.11.2022 is being forwarded to you for your reference.

In light of the above, a monthly report comprising of video clips / photographs must also be submitted to this Council for onward submission to DEPwD, MoSJ&E, GOI.
