CIRCULAR

In the light of RPwD Act, 2016 and based on the recommendations derived during the National workshop held on 6-7 June 2019 at Guwahati and the subsequent several meetings of the Core Committee on convergence of teachers training programmes and in consonance with of NEP 2020, development of new training programmes in special education in various disability specializations were approved by the General Council of RCI in its meeting held in 7/08/2020.

2. In exercise of the powers conferred under section 18 of the RCI Act, 1992, after convergence, the following new training programme at diploma level in different disability specializations have been developed:

Diploma in Education Special Education (Multiple Disabilities)-D.Ed.Spl.Ed. (MD)

3. The above training programme as approved by the Executive Committee of RCI in its 84th meeting held on 22-25/01/2022 and by the General Council of RCI in its 44th meeting held on 21/2/2022 will henceforth be implemented from the academic session 2022-23 at RCI approved training institutions. The new curriculum of the training programme is available in the Council's website: www.rehabcouncil.nic.in

4. The existing training programme "D.Ed.Spl.Ed.(MD) and D.Ed.Spl.Ed.(DB)" will be discontinued w.e.f. the academic session 2022-23. However, candidates who already given admission till 2021-22 will continue their courses.
